



**PET NETWORK HUMANE SOCIETY  
JUNIOR VOLUNTEER AGREEMENT**

This agreement between \_\_\_\_\_ (Volunteer’s Legal Guardian),  
\_\_\_\_\_ (Junior Volunteer), and Pet Network Humane Society (Pet Network) is intended to demonstrate the seriousness with which we treat all of our volunteers. The intent of the agreement is to assure you of our appreciation of your services, to express your commitment and understanding to Pet Network, and to indicate our commitment to make your volunteer experience a mutually productive one.

**I. Volunteer’s Commitment**

1. I agree to perform my volunteer duties to the best of my ability. I agree to act responsibly and to not engage in any activities that may frighten or harm any of the pets on premises. I understand that my parents will be called and I will be sent home if I upset the animals or staff or am disruptive in any way. I also understand and agree that I am not allowed to leave the premises with any of Pet Network’s animals.
2. I agree to check in with the Volunteer Coordinator (or his/her designated representative) and to sign in **and out** at the reception desk computer. I understand no one else will be authorized to give out or sign off on community service hours. (Pet Network’s computer log will be the record of your community service volunteer hours, so please make sure it is accurate.)

**II. Volunteer’s Legal Guardian’s Commitment**

1. I realize that liability may arise from negligence or carelessness on the part of Pet Network from property owned, maintained or controlled by them, including but not limited to animals, machinery, equipment, facilities, and terrain. Nonetheless, in consideration of Pet Network Animal Friends allowing me to perform volunteer hours, I HEREBY, WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS AND PROMISE TO INDEMNIFY AND NOT TO SUE Pet Network Animal Friends from any and all claims including but not limited to claims arising from any and all damages and/or personal injury which may be sustained by me or my child directly and indirectly in connection with or arising out of any action of Pet Network Animal Friends.

I understand that I have chosen to let my child volunteer unsupervised in an environment that may lead to injury. And I, HEREBY, WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS AND PROMISE TO INDEMNIFY AND NOT TO SUE Pet Network Humane Society from any and all claims on behalf of myself and/or my minor child.

2. I understand the Junior Volunteer Program is still in its probationary stage, and I might be called if my child is disruptive in any capacity and I will be asked to pick him/her up at the earliest possible time. I am aware Pet Network may begin scheduling the Junior volunteers as to only allow four Junior volunteers at a time.
