

Pet Network Boarding & Services Contract

This is a contract between Pet Network Humane Society (hereinafter called "Pet Network") and the Pet Owner (hereinafter called "Owner") whose signature appears below.

1. Owner agrees to pay the rate for boarding and/or services in effect during the date(s) the pet(s) are checked into Pet Network and owner is aware the rates may vary based on season, holiday (boarding) coat condition, behavior & size (grooming) & other factors.
2. Owner further agrees to pay all costs and charges for special services requested and any emergency veterinary costs for their pet during the time said pet is in the care of Pet Network Boarding.
3. Owner agrees that the pet shall not leave Pet Network until all charges are paid.
4. By signing this Contract and leaving his/her pet with Pet Network Boarding, Owner certifies the accuracy of all information given about said pet to Pet Network staff.
5. Pet Network Boarding staff shall exercise reasonable care for the pet delivered by the Owner to Pet Network Boarding. It is expressly agreed by Owner and Pet Network Boarding that the Pet Network Boarding's liability shall in no event exceed the lesser of the current value of a pet of the same species or the sum of \$500 per animal boarded.
6. Owner specifically represents to Pet Network Boarding that the pet has not been exposed to rabies, parvo or distemper within a 30 day period prior to boarding and that any history of aggression (pet or human) and/or escape history has been fully disclosed.
7. IF YOUR PET BECOMES ILL OR IF THE STATE OF THE ANIMAL'S HEALTH OTHERWISE REQUIRES PROFESSIONAL ATTENTION, PET NETWORK BOARDING AT ITS SOLE DISCRETION, MAY ENGAGE THE SERVICES OF A VETERINARIAN, ADMINISTER MEDICINE, OR GIVE OTHER REQUISITE ATTENTION TO THE ANIMAL, AND THE EXPENSES THEREOF SHALL BE PAID BY THE OWNER. Pet Network Boarding staff will make a reasonable attempt to contact Owner prior to engaging such services when possible and practical.

8. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assignees of the Owner and Pet Network.

9. The Owner shall hold harmless Pet Network, its staff, board members, volunteers and assignees for any damages. Pet Network Boarding will make every reasonable effort to ensure the safety, comfort and good health of the Owner's animal(s). Pet Network is not responsible for any accidents due to Acts of God, for example, earthquake or fire. Pet Network Boarding is not responsible for any theft.

10. If said pet is not picked up within the agreed upon appointed time given with a 7 day variance, Pet Network Boarding has the legal right to re-home the animal as we deem fit. Pet Network Boarding will make every effort to contact the Owner prior to re-homing. In addition, Pet Network Boarding has the right to charge Owner for each day the pet is left over agreed upon length of stay. Any owner abandoning a pet will be reported to the Washoe County Regional Animal Control Services

11. Pet Network Boarding is not responsible for any damage to bedding, toys, etc. brought in by Owner for pet during it's time of boarding or other services.

12. Pet Network highly recommends that owners provide their pet's food during boarding. A sudden change of food can cause animals digestive and health issues.

13. Owner agrees to pay for services requested verbally (extended stay, late night pick-up, grooming/bathing services, non-required veterinary services etc).
