In 2020, Pet Network adopted out 408 animals, finding them new families in our own community and far beyond. Many of these animals were transferred in from other shelters in our region. These shelters are generally under resourced and overburdened, which can lead to euthanasia of adoptable pets in their community. To reduce their community's need for preventable euthanasia, Pet Network transports animals into our facility to provide a second chance at a new home. Our staff provide individualized support to our adopters, offering education and advice to help make the transition to home life as smooth as possible for the pets and the humans.
